VI. Unfinished Business:

- District Calendar updates and next steps
 - Values represented by naming holidays on the calendar are supported by the School Committee's recommitment to anti-racist resolution. Values:
 - (1) By not naming the holidays, we make them invisible instead of celebrating these dates.
 - (2) Recognizing, remembering, and honoring history.
 - (3) Celebrating important founding peoples of our country, who worked for liberty and justice for all.
 - (4) Builds community in our schools.
 - (5) Recognizing the names of holidays is a way of acknowledging all students, staff, families, and community members.
 - Kelly will take the lead on drafting a letter to the calendar committee.

- Laurie will follow up with Sharon and Leah to request their suggestions for a path to the School Committee and with Ann Marie Stoica, as head of the calendar committee. Recommendations:
 - (a) All federal holidays to be acknowledged by name
 - (b) Indigenous People's Day to be called by that name
- If deemed appropriate, Laurie will schedule a meeting with Ann Marie to share these changes with the calendar committee before the SC meeting on 1/26/22
- Kelly moves that we will address the calendar committee to address the school committee to make these changes to the district calendar. Lindsay seconds. Unanimous vote of approval.

■ NRSD March Professional Development Day

- Propose a panel discussion focused on equity and connecting the district to the community.
 - (1) What would be the focus of the panel?
 - (a) Sharing resources and connections schools could make with community experts or organizations
 - (b) Sharing personal stories (like Scott's) to advocate for awareness
 - (i) Help students see they are valued
 - (ii) Appreciate wide variety of learners as assets to our world
- Motion: Kristin moves to submit a proposal to the NRSD Teaching & Learning Dept. for a panel presentation for 3/18 PD day and to create a subcommittee to plan for the panel presentation. Scott Cummings seconds. Unanimous vote of approval.
- 9:18 p.m.: Motion by Kristin to NOT propose a panel for the NRSD Teaching & Learning Dept. for a panel presentation for 3/18 PD day. Seconded by Kelly. Unanimous vote.
 - Next steps instead will be to connect Teaching & Learning to NASJA to potentially coordinate this panel as DEARJ, with its limited time, needs to focus on its advisory work to the School Committee.

 - Review of proposed process and structure
 - Discussion:
 - (1) Should members of DEARJ communicate/connect monthly with stakeholders/existing groups Students for Social Justice, GSA, NASJA, SEPAC....?
 - (2) Mission question: How do we support the existing structures within the buildings/district to support and endorse DEI work?
 - (3) Further discussion to follow at future meetings.

 - Overlaps with mission, vision, and values- so moved onto agenda items in new business.
